#### 2. Information

Bombardier Recreational Products as the manufacturer of the ROTAX 912 engine series has released Alert Service Bulletins ASB-912-061 and ASB-912-061UL. These alert service bulletins claim for immediate replacement of the fuel hose on the pressure side of the fuel pump.

As a reaction of these alert service bulletins, the German national aviation authority Luftfahrt Bundesamt has released Airworthiness Directive LTA D-2012-227. This AD claims for immediate replacement of the fuel hose on the pressure side of the fuel pump prior to next flight.

•	NOTE	LTA D-2012-227 is not applicable for REMOS aircraft of any serial number.

#### 3. Reason

ASB-912-061 and ASB-912-061UL are applicable for engine configurations using genuine ROTAX fuel hoses. The aircraft manufacturer may configure the engine and its equipment provided by ROTAX as per the individual demands of the engine integration. In REMOS aircraft, ROTAX fuel hoses are not installed. REMOS aircraft are fitted with fuel hoses supplied by a third party manufacturer. ROTAX fuel hoses are not installed on any REMOS aircraft and it is impossible to install them as spare parts. Therefore the ROTAX alert service bulletin and the LBA AD are not applicable.

#### 4. Recommendation

Fuel hoses on REMOS aircraft are operated on condition. A fixed time interval for replacement is not defined. Nevertheless, the ROTAX maintenance manual claims for replacement every 5 years. The replacement is not mandatory on REMOS aircraft, though recommended.
